Crookwell 3 Wind Farm

Project Status

For the past few weeks, you may have noticed that Crookwell 2 has not been operational. This is due to a planned outage which was necessary to conduct the required work to connect Crookwell 3 to the substation.

Activities On Site

- **Roads**
 - ✓ As per usual and till the end of the project, Divall's has been maintaining the internal roads in good condition.
- **Wind Turbine Foundations**
 - ✓ 100% of the turbines (16) have been fully assembled.
 - ✓ Mechanical and electrical works inside the turbines has been completed.
- **Grid Connection**
 - ✓ RJE Global is currently trenching and carrying out cabling works in Crookwell 2, to successfully connect the substation to Crookwell 3.
 - ✓ RJE Global has successfully installed the reactive plant, 33kV breakers and protection panels.
 - ✓ The new substation building is being built in South Australia. Installation on site is expected by Q2 2024. The building is being delivered in two separate trucks. The first truck arrived on Sunday 26th afternoon and the second truck is expected on Friday 31st Morning.

Landscape Screening Program

As part of the Development Consent for Crookwell 3 Wind Farm, GPG is implementing its landscape screening program. Do You Know About?

Outage at Crookwell 2 Wind Farm



Between April 8th and May 21st, a planned outage occurred at Crookwell 2 Wind Farm. The purpose of this outage was to connect Crookwell 3 to the substation.

During this outage, Transgrid installed a new bus bar where Crookwell 3 will be connected. As a result of this modification, Crookwell 2 had to change its point of connection to the same bus bar.

Crookwell 2 will be reenergised within the next couple of weeks, together with Crookwell 3, which will be energised for the first time to undergo a schedule of tests before it begins operations.



The first part of the substation building has been delivered at Crookwell 2 Wind Farm.
